# 1. TOURNAMENT MANAGEMENT

## 1.1 Management

The 2<sup>nd</sup> **VGM JUNIOR TROPHY 2017** (hereinafter referred to as the **Championship**) shall be managed by a Tournament Committee (hereinafter referred to as the **Committee**) whose decisions in all matters relating to the Championship shall be final.

## 4. ELIGIBILITY

The Championship is open to BOYS and GIRLS Under 18 years old (Born after 1/1/1999) who are Amateur Golfers in accordance with the Rules of Amateur Status as approved by the R&A Rules Limited and will be conducted over the following age group:

#### Note:

In the event of less than 4 players registered in a category, the Committee will merge the groups and announce officially before the tournament begin.

# 5. PLAYING FORMAT

All groups play Stableford format over one (1) round of 18 holes.

## **STABLEFORD FORMAT GUIDE**

- Stableford Competition is still a **STROKE PLAY** format, except that scoring is based on fixed score of each hole.
- The scoring in Stableford competition is made by **POINT** awarded in relation to a fixed score at each hole as follow:

SCORE	EXPLAINATION	POINT
More than one over fixed score or no score returned	Double Bogey (+2) or worse	0
One over fixed score	Bogey (+1)	1
Fixed Score	Par (0)	2
One under fixed score	Birdie (-1)	3
Two under fixed score	Eagle (-2)	4
Three under fixed score	Albatross or Double Eagle (-3)	5

• The winner shall be the competitor who scores the highest number of points at the end of the Championship.

# 6. PRIZES STRUCTURE

2<sup>nd</sup> VGM JUNIOR TROPHY 2017

Prizes will be awarded as follows:

a) Champion of VGM JT 2017 - Highest Points Overall (Except Category U10)

b) Winner, 1st and 2nd Runner Up - Highest Points in Each Category

# 7. ENTRY FEES & CLOSING DATE FOR REGISTRATION:

 The entry fee for 2 days is 2.300.000 VND (Two million and three hundred thousand Vietnam dong) including green fee, caddy fee (not including tips) for 01 practice day and 01 official competing day, 01 lunch, welcome dinner and gala dinner.

The entry fee for 1 day is 1.500.000 VND (One million and five hundred thousand Vietnam dong) including green fee, caddy fee (not including tips) for 01 official competing day, 01 lunch and gala dinner.

(Parents of players have to pay **500.000 VND/ dinner/ person** to join the welcome and gala dinner parties (register and pay fee before the closing date **October 5**<sup>th</sup>). Supporting **1.000.000 VND** airfare for golfers from the South who register and pay entry fees before **September 31**<sup>st</sup>, **2017**. Providing bus transferring players from Hanoi to golf course and vice versa.)

\* All fees are NOT refundable if players withdraw registration AFTER the closing date.

- All entries are based on first come first serve basis.
- The Committee is entitled to reject any entries without giving any reasons. The field is limited within 72 players.
- All registrations have to be made in the **Official Entry Form** and submit to Vietnam Golf Magazine by **4:00 p.m. Thursday, October 5**th, **2017**:

# 8. WITHDRAWAL

There will be **NO** refund for withdrawal after **October 5**th, **2017** except for special situations.

#### 9. RULES OF PLAY

The Rules of Golf and Rules of Amateur Status as approved by R&A Rules Ltd and The USGA, their interpretations as contained in the "Decisions on the Rules of Golf", this Conditions of Competition, VGA Championship Hard Card 2016 and any additional Conditions of Competition together with the additional Local Rules established by the Tournament Committee for the Competition.

## **10. FLIGHTS AND TEE TIMES**

- The Tournament Committee will make the draws and the starting times for the official rounds and will be sent to the player and posted at the Clubhouse and the Official Hotel. Such posting will be considered sufficient notice for information and distribution. The Committee reserves the right to vary the starting times, at its absolute discretion, before tee-off time.
- The player shall start at the time laid down by the Tournament Committee. In the absence of circumstances which warrant waiving the penalty of disqualification as provided in Rule 33-7:
  - If a player arrives at his starting point ready to play within five minutes after his starting time, the penalty for failure to start on time shall be two strokes at the starting hole.
  - After 5 minutes, the player will be **DISQUALIFIED**.

## 11. TRANSPORTATION

Players must not ride on any form of transportation during a stipulated round unless authorized by the Committee.

# PENALTY FOR BREACH OF CONDITION:

Two strokes for each hole at which any breached occurred. Maximum penalty per round: Four strokes.

Use of any unauthorized form of transportation must be discontinued immediately upon discovery that a breach has occurred. Otherwise, the player is **DISQUALIFIED**.

#### 12. CADDIE

Private caddie are not allowed in this tournament. Each player will be assign 01 caddie for all competition days of the tournament.

#### PENALTY FOR BREACH OF CONDITION:

Two strokes for each hole at which any breached occurred. Maximum penalty per round: Four strokes.

A player having a caddie in breach of this condition must immediately upon discovery that a breach has occurred ensure that he conforms to this condition for the remainder of the stipulated round. Otherwise, the player is DISQUALIFIED.

# 13. DECISIONS OF TIES

In the event of a tie, the tie shall be decided by a count-back system of matching scorecards in the following order:

- a. Last 9 holes.
- b. Last 6 holes.
- c. Last 3 holes.
- d. Last hole (Hole 18)
- e. In the case the result still in a tie, the winner will be decided by lot.

**Note:** Where there is more than one (1) point start, it is considered that the last 9 holes, last 6 holes, last 3 holes and the last hole is considered to be holes for 10 - 18, 13 - 18, 16 - 18, and the 18th hole.

# 14. INDEMNITY / LIABILITIES

In signing the Entry Form, participants in this Championship shall indemnify and not hold liable, VGM, VGA, the Sponsors, the Organizers or the Host Club for any loss or damages to their equipment or personal belongings or harm or any form of injuries that the participants may suffer as a result of the participation in this Championship.

## 15. DESICIONS

If the Committee has appointed a referee, his/her decision is final (Rule 34-2). In the absence of a referee, any dispute or doubtful point on the Rules shall be referred to the Tournament Committee, whose decision shall be final (Rule 34-3).
